## **"MOST WANTED" ROBBERY FUGITIVE & GIRLFRIEND ARRESTED IN MUNHALL**

PITTSBURGH, PA – This morning, Sheriff's Deputies apprehended "Most Wanted" fugitive, D'ondre Kelly, 23 years of age from Braddock. Kelly had been wanted since July 3, 2018 on a criminal bench warrant due to violating the terms of his probation/parole. He pled guilty to robbery-inflict threat immediate bodily injury, which originated from a 2015 incident.


In the early hours of September 21, 2015, the victim contacted authorities stating that she had been assaulted during an attempted robbery in an elevator at an apartment complex in Wilmerding. The victim had been heading down to the ground floor, when the elevator stopped and Kelly entered. Upon the door closing, Kelly asked the victim if she had any money, to which she responded "no." Kelly replied, "Well you better give me some money" and punched the victim in the left side of her face. Furthermore, he went through her jacket pockets in search of belongings from the victim, which he found nothing. When the elevator door re-opened, he fled the scene. In May 2016, Kelly pled guilty and part of his sentencing included probation, which was violated in July 2018.

Over the course of the last few days, Sheriff's Deputies obtained information

that Kelly was staying with his girlfriend in Munhall. This morning, Deputies surrounded the residence in the 1300 block of Martha Street around 7:30AM. After a few announcements at the home with no response, Deputies were able to view Kelly through a window and made entry into the home. After a brief search, Kelly was found in the living room attempting to hide from Deputies and was taken into custody, without incident.

Additionally, Sheriff's Deputies apprehended Kelly's girlfriend, Cherri Barber, 29 years of age. Barber had been wanted by the City of Pittsburgh on an arrest warrant since Tuesday due to failure to appear regarding a July 25, 2018 incident. Barber allegedly damaged and stole pieces of her sister's boyfriend's motorcycle and was charged with theft by unlawful taking and criminal mischief. Barber was scheduled to appear at a preliminary hearing on September 25<sup>th</sup>, which she failed to do resulting in the issuance of a warrant later that day.

Both Barber and Kelly were transported to the Allegheny County Jail, where they are being lodged.
